The validity in the period of the 'consent to operate' earlier granted u/s 21 of Air (Prevention & Control of Pollution) Act, 1981 vide no. R16LDH3CTOA3855784 dated 06.04.2016 is hereby extended upto 30-06-2024 with same terms & conditions as mentioned in the original consent granted to the industry as well as extensions made thereto and with special condition that

- 1) The facility will obtain the Environmental Clearance as required under EIA Notification, 2006 from the Competent Authority for installation of new incinerator of 200kg/hr capacity using old incinerator of 200 kg/hr as stand-by during breakdown of new incinerator end up-gradation of autoclaving capacity due to installation of 2 new autoclaves of capacity 1250 Ltr/batch and capacity 3000 ltr/batch, within 06 months or will submit the exemption letter from the MoEF in this regard.
 - 2) The CBWTF operator will provide the separate partition for the storage of untreated autoclave Bio-medical waste, within 15 days.
 - 3) The CBWTF operator will complete the remaining work regarding mapping of all the HCFs catered by its on the GPS website within one month.
 - 4) The industry will obtain the permission for the use/abstraction of ground water as per the requirements of Central Ground Water Authority (CGWA). In absence of obtaining of permission, the operation of the industry is entirely at its risk and cost and the Board will not be responsible for any loss, in case the CGWA will prohibit the abstraction/use of water on account of non-obtaining of such permission.
 - 5) The industry shall comply with the manufacture, storage and import of Hazardous Chemical Rules, 1989 (as amended) and submit the details on onsite emergency plan, safety reports and safety audit reports in accordance with the manufacture, storage and import of hazardous chemical rules, 1989, in case the industry or installation handling hazardous chemicals quantity equal to or more than the threshold quantity specified in the said rules.
 - 6) The industry shall provide adequate arrangement for fire fighting and against any accidental leakage/discharge of any air pollutant/gas/ liquids from the vessels, mechanical equipment's etc, which are likely to cause environmental pollution. The industry to obtain necessary permissions from the concerned authorities like Municipal Corporation, Ludhiana and Deptt. of Labour/Director of Factories, Punjab with respect to the above safety measures.
- This letter for extension of consent be appended with the original consent issued vide no. R16LDH3CTOA3855784 dated 06.04.2016 under Air (Prevention & Control of Pollution) Act, 1981.
